GANDER YONDER PICTURES TERMS OF USE

Please read the terms and conditions below ("Terms of Use") carefully before proceeding to purchase DVDs, stream video or procure a Digital Site License. This Agreement licenses video content to you from Gander Yonder Pictures B.V. ("Licensor"). By selecting the Order button, you ("Licensee" or "You") are confirming that you have read and understand this Agreement and agree to be bound by the terms of this Agreement. If you do not agree with the terms of this Agreement, do not select the Order button.

1. Definitions

- a. Authorized Users: Full, part-time or contract faculty; currently-enrolled students; staff; researchers or independent contractors using the content for individual use; casual, "walk-in" on-site Authorized Users customarily granted access to the educational institution and using the content for individual use.
- b. Classroom Use: Streaming, exhibition or display of Streamed Content or DVD Content in classrooms or other venues, for audiences of more than one person, conducted without charging admission. In this context, Streamed Content may be exhibited by any means not requiring additional digitization, alteration, duplication or reproduction.
- c. Distance Learning: Specific coursework conducted via electronic, digital or other communications network (including Internet and Intranet) by students enrolled for that purpose through the Licensee's Unified Campus as defined below.
- d. DVD Content: All materials purchased and/or licensed from Gander Yonder Pictures for exhibition or display via DVD or other physical media, including, but not limited to, video, audio, graphics, text, images, and interactive media.
- e. Educational Use: Exhibition or display of Streamed Content or DVD Content in educational markets including, but not limited to, primary schools, middle schools, high schools, colleges, universities, libraries, museums, hospitals, companies, and nonprofit organizations and individual exhibition or display of Streamed Content or DVD Content by Authorized Users studying, researching or working through primary schools, middle schools, high schools, colleges, universities, and distance learning programs.
- f. License: The electronic or printed paper permission granted to you under these Terms of Use for the purpose of streaming, displaying or exhibiting the Streamed Content or DVD Content to Authorized Users.
- g. Streamed Content: All materials purchased and/or licensed from Gander Yonder Pictures for streaming purposes including, but not limited to, video, audio, graphics, text, images, and interactive media. The Streamed Content will be identified on invoices generated by the Licensor.
- h. Unified Campus: A geographically discrete setting which constitutes the principal place of business of the Licensee.

2. Grant of Rights

Licensor makes its content available to educational institutions through several platforms, including by means of physical media (DVDs), via streaming licenses and by Digital Site Licenses enabling educational institutions to host and stream content online through their access-controlled server. In addition to the terms and conditions set forth herein, the following license terms shall apply to each of the following respective media:

a. DVD Purchase

i. Purchase of any Gander Yonder Pictures DVD program is for Educational Use for life of the DVD. Gander Yonder Pictures DVDs are not licensed for screenings in which admission fees are charged, including but not limited to theatrical screenings.

b. Streaming Licenses

i. Subject to the restrictions set forth herein, Licensor grants Licensee a limited, non-exclusive license for the Term (defined at Section 2(b)(ii) below) to stream, display and exhibit the Streamed Content for Classroom Use and in other related venues for the Educational Use of Authorized Users. Streaming licenses include access via IP authentication for unlimited simultaneous users. Any other use of the Streamed Content must be licensed through special arrangement with the Licensor.

ii. Term. The term of this License Agreement with respect to Streamed Content shall be concurrent with the length of the license chosen (i.e. 30-day, 1-year, 3-year, or other agreed-upon term). Upon expiration, non-renewal, or any termination of the license, all Licensee's rights to use the Content shall cease. License period commences at the time the license is purchased.

iii. All other rights not expressly granted are reserved by Licensor. Streamed Content may not be rented, loaned, sub-leased, re-sold or sub-licensed to others. Streamed Content may not be digitized, transferred, altered, duplicated or reproduced by any means except as expressly provided in this license without prior written authorization of Licensor.

iv. This streaming license is expressly conditioned upon receipt of payment by Licensor of all applicable fees and taxes.

c. Digital Site License

i. Subject to the restrictions set forth herein, licenses for educational institutions to host and stream content online through their own access-controlled server or third party content repository may only be shared within any single, geographically unified campus, and with distance-learning classes and students who are enrolled by the Licensee for study conducted through that campus. Sharing of Licensor's streamed content between two or more campuses, or with other institutions, or with individuals, classes or groups who are not specifically affiliated through employment or enrollment with the licensee, is not permitted without the express authorization of Licensor.

i.

ii. Term – Perpetual License. If You select a perpetual license when ordering, the term of this Digital Site License shall be life of file and may only be revoked if Licensee materially breaches this Agreement, or if the Streamed Content is withdrawn due to errors or third party claims (including claims of infringement).

iii. Term - Limited License. The term of any Limited Digital Site License shall be concurrent with the length of the license chosen (i.e. 1-year, 3-year, or other agreed-upon term). Upon expiration, non-renewal, or any termination of the license, all Licensee's rights to use the Content shall cease. License period commences at the time the license is purchased. Upon expiration, non-renewal, or any termination of the Digital Site License, all of Licensee's rights to use the Content shall cease. All Content in all formats must be erased, deleted, or destroyed upon expiration or any termination of this Agreement. Failure by Licensee to delete all Content covered by this agreement at the end of the term or upon any termination of the license will be regarded as a violation of U.S. Copyright law and subject to legal action.

iv. Licensor will provide Licensee access to download Streamed Content to host on an access-controlled streaming service for use of Authorized Users only. In case Licensee purchased a DVD with the Digital Site License, Licensee is authorized to create a file from the DVD for that same purpose.

3. Restrictions

c. Content licensed for Educational Use may only be shared by Authorized Users within a single, geographically Unified Campus. Permission is also granted for Authorized Users of Distance Learning from that campus and Authorized Users at a satellite campus of that Campus, provided that they are served by the same information network as the main campus and bear the same institutional name and affiliation. Sharing of Streamed Content with other institutions, or with users not specifically affiliated with the Unified Campus is not permitted.

ci. Multi-campus K-12 streaming is licensed on a case-by-case basis. Please contact our office to make specific arrangements.

cii. Institutional streaming licenses for 30-day, 1-year, 3-year and life of file terms permit all Educational Uses, including Classroom Use. However a personal viewing license does not permit use of Streamed Content for Classroom Use.

ciii. Licensee may not make or distribute copies of the Streamed Content, or electronically transfer the Streamed Content from one computer to another or over any other Internet Server or other communications network, except as permitted by these Terms of Use. You may not decompile, reverse engineer, disassemble, or otherwise reduce the Streamed Content to a human-perceivable form. You may not modify, transfer, or create derivative works based on the Streamed Content or any part thereof.

civ. You may not infringe on or violate the intellectual property, privacy, publicity, or other

rights of third parties whose work is embodied in the Streamed Content, including the rights of any third parties in any sound recordings, musical compositions, photographs, artwork, literary creations, or other copyrightable works of any kind or nature.

4. Trademarks

The GANDER YONDER PICTURES service mark and logo belong to Licensor and all other trademarks on this site are the property of their respective owners. Except as permitted by applicable law, Licensee is prohibited from using any of the trademarks appearing on this site without express written consent from their respective owners.

5. Representations and Warranties of Gander Yonder Pictures

All information, products and other content (including third party information, products and content) included in or accessible from Licensor's content are provided "as is" and without warranties of any kind (express, implied and statutory, including but not limited to the warranties of title and noninfringement and the implied warranties of merchantability and fitness for a particular purpose), all of which Licensor disclaims to the fullest extent permitted by law. Licensee's use of the Content is at licensee's sole risk.

6. Representations and Warranties of Licensee

- a. Licensee warrants that all information provided is true and accurate. Licensor may terminate Licensee's rights to any or all service if any information Licensee provides is false or inaccurate.
- b. Licensee agrees to provide adequate security for protection of Content from piracy, theft and any other misuse while Content is stored on systems controlled, owned, leased or otherwise contracted for use by the Licensee. Licensee further agrees to assume full responsibility under the copyright laws of the United States for failure to do so.

7. Governing Law

These Terms of Use are governed by the laws of the State of New York, USA. Any legal action arising out of this Agreement shall be brought in New York, New York, USA or any other district court having jurisdiction to hear any dispute arising out of this Agreement.

8. Miscellaneous

- a. Licensor reserves the right to refuse service and terminate accounts at its sole discretion, for cause, including, but not limited to, if it reasonably believes Licensee's conduct violates applicable law or is harmful to Licensor or its partners and affiliates.
- b. Licensor's rights, including but not limited to all rights of remedy for Licensee's breach, shall survive the termination of this Agreement.
- c. Licensor reserves the right to change, modify, add, or remove portions of these Terms of Use or this service or the policies incorporated herein by reference upon notice to Licensee. Any revisions to this Agreement that materially affect Licensees' existing rights -- such as deletion or modification of features, and/or the scope of and service of

support provided -- shall require Licensee's written consent. Pricing and product title library are subject to change without notice.

d. No delay or failure of Licensor to take action under these Terms of Use will constitute a waiver by Licensor, unless expressly waived in writing by Licensor.

e. If any part of this Agreement is held invalid or unenforceable by a court of competent jurisdiction, the remainder of the Agreement shall be interpreted so as to reasonably affect the intentions of the parties.

f. These Terms of Use constitute the complete agreement of the parties and supersede any prior written or oral agreement. No change, amendment or modification of any provision of these Terms of Use shall be valid unless set forth in a written instrument signed by the party subject to enforcement of such amendment.
